### SECTION 2 - TAX DETAILS

Supplying your Tax File Number (TFN) to the Fund is optional. Before you decide whether to provide your TFN, we are required to notify you of the following information:

- The Trustee is authorised under the Superannuation Industry (Supervision) Act 1993 to collect your TFN.
- Your TFN is confidential and it is not compulsory to provide it. However, if you choose not to provide it now or later, you may have to pay significantly more tax on your contributions than you should, we may not be able to accept certain types of contributions and each withdrawal you make will be subject to tax at the highest marginal tax rate. It may also prove more difficult to locate or transfer in any benefits due to you, without your TFN.
- If you do choose to provide your TFN, it will only be used for lawful purposes. These include finding or identifying your super where other information is insufficient, calculating any tax payable on contributions or payments provided and providing information to the ATO. These purposes may change in the future due to legislative requirements.
- If you provide your TFN, the Trustee may then also provide your TFN to the Trustee of any other super fund provider, to which your benefits may be transferred in the future, unless you advise us in writing not to do so. Your TFN will not be provided to any other party or individual.

## SECTION 4 - NOTE TO EMPLOYERS

Under the Choice of Fund legislation this nomination form is a legally acceptable means of an employee nominating their choice of super fund.

It is an allowable alternative to an Australian Taxation Office's standard Choice Form.

WA Super (WA Local Government Superannuation Plan - WALGSP) is a complying super fund and will accept Superannuation Guarantee contributions. Below is a copy of WA Super's Compliance Statement and details of how you can pay contributions into WALGSP.

## SECTION 5 - COMPLIANCE STATEMENT FOR EMPLOYERS

I certify, on behalf of the Trustee of WA Super that:

- The Fund is a resident regulated super fund within the meaning of the Superannuation Industry (Supervision) Act 1993 (SIS ACT). The Fund holds Registrable Superannuation Entity License Number L0001137, and RSE Registration Number R1004380.
- The Fund is a complying super fund within the meaning of the SIS Act and has never received a notice of non-compliance from the Australian Prudential Regulation Authority.
- The Fund is able to accept superannuation contributions for eligible persons. These contributions are maintained and subsequently paid only in accordance with the Superannuation Industry (Supervision) Regulations 1994.
- The Fund is not subject, and has never previously been subject, to a direction under Section 63 of the SIS Act.
- This letter satisfies the requirements of Section 3, Part B of the Standard Choice Form issued by the Australian Taxation Office that the Fund is:
  - (i) a complying fund,
  - (ii) will accept Superannuation Guarantee contributions on behalf of eligible persons from an employer, and
  - (iii) provides details of how an employer can make contributions to WA Super.
- The Fund offers insurance cover that meets the minimum requirements, set out in the Superannuation Guarantee (Administration) Act 1992, of a fund to be offered by an employer where an employee does not choose a fund.
